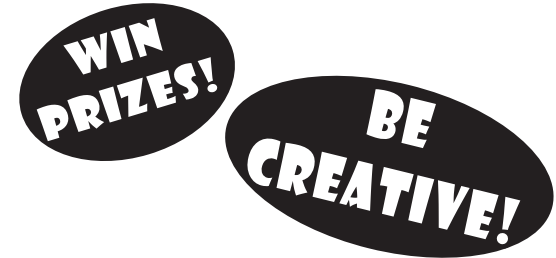

GUIDELINES/RULES for the Pikes Peak Children's Museum Logo Contest

Each PPCM logo entry must include a completed entry form, a signed consent form, and, of course, your masterpiece logo design.

The PPCM logo competition is open to all children in El Paso County from ages 1-11. Schools and individual children are all eligible.

REGISTRATION/SUBMITTING ENTRIES

- Your school/family can submit as many entries as eligible.
- One entry per student/child.
- Please attach completed entry and consent forms for each logo entry.
- The artwork should be placed on top of the entry & parental consent forms and should be attached by a staple in the top left corner of the page.
- Drop off your entries at any PPLD library, the BEMIS School of Art, or participating elementary schools (listed on PPCM website, www.pikespeakchildrensmuseum.org) no later than April 17, 2009.

DESIGN GUIDELINES

- The logo should be presented on a white sheet of 8.5 x 11 inch paper.
- No letters, words, or print shall be incorporated into the design. The logo should be based upon symbols and ideas representing a children's museum and the unique qualities of our region.
- Inappropriate content will be dismissed for consideration.
- The logo may be in pencil, crayons, felt tip or paint, or can be done using a computer drawing/design program.
- Unfortunately, we can't accept entries which use additional materials to create 3D effects.
- Please encourage your students/children to create original designs, with the understanding that the design may be altered in the final rendition of the logo by a professional graphic designer.

CONTEST RULES

- Open to all children between the ages of 1-11.
- Must be a resident of El Paso County.
- Parental consent form must accompany the entry.
- The logo designs will become property of the PPCM and will not be returned.
- Please keep a color photocopy for your records.
- No more than one original design per child.

JUDGING AND PRIZES

How is the contest judged?

Children's logo designs will be judged on artistic merit, creativity, representation of a children's museum, and representation of our community. An independent panel from the Colorado Springs Fine Art Center and the Bemis School of Art will select the top five designs, from which the public, at all Pikes Peak Library District libraries, will help select the top three finalists.

PRIZES

The top three finalists will each receive:

- Gift certificate for an art class at the Fine Arts Center's Bemis School of Art
- Artist's Kit provided by the Fine Arts Center's Bemis School of Art
- His/Her logo framed and permanently displayed at the future Pikes Peak Children's Museum
